COPY POST'S EBAY CONSIGNMENT RULES AND GUIDELINES

1. JJNB,LLC D/B/A Copy Post (herein known as "Copy Post") will NOT accept anything for auction that is not legal to possess, sell, ship, or requires a special license to obtain. This includes but not limited to firearms, liquor, and most hazardous materials. We also will not auction any pornographic materials of any type. We reserve the right to refuse to auction any item at our discretion.
2. The fees for the consignment service is are currently 20% for the first \$200 of the selling price, 15% of the selling price between \$200.01 and \$300, and 10% of the selling price over \$300. In addition to the Ebay pricing of 5.25% of the first \$25, 2.75% of the selling price between \$25.01 and \$1000 and 1.5% of the selling price over \$1,000. In addition there is a 2.9% Ebay transaction fee. CopyPost charges a \$5.00 drop-off fee that is refunded if the Copy Post commission is over \$5.00, this fee is not redeemed if the item does not sell.
3. By setting a starting bid you are agreeing to accept at least that amount minus our fees outlined above in exchange for merchandise listed on form. Once the auction has started, it will not be stopped until it ends after the normal auction cycle.
4. We are not responsible for technical difficulties caused by the auction service, our internet service providers, our picture hosting server, or failure of any portion of the internet in general. If the auction service does have difficulties during the final stages (generally 15 minutes) of the auction, the auction could be reposted if we request it. This does not include slow response time due to volume.
5. All items auctioned off are sold "AS-IS", and without warranty of any kind, expressed or implied, except as provided by the manufacturer. However, we DO guarantee that the item is as posted on the auction listing and allow the winning bidder one business day after receipt of item to verify this before we consider the auction fully closed and we can give you payment for your item. By giving bidders this window, we give them more of a reason to trust us as a seller and it will generally bring more bidders into the bidding process. Please **be honest** in your descriptions of the item and detail flaws that would affect its value.
6. Copy Post reserves the right to add to your description as deemed necessary to accurately describe the item. This may include measurements and/or the listing of defects and imperfections.
7. Items that did not get bids must be picked up from Copy Post within 1 month of auction close. Items left here longer then 1 month after auction close without prior arrangements may be donated or disposed of at our decision.
8. All items will be packaged by Copy Post to exceed all shipping guidelines. However, in the extremely unlikely event that a package does get damaged or lost in transit, it is your responsibility to supply Copy Post with proof of value in order to file a claim with the carrier. Copy Post is NOT responsible for lost or damaged items in transit. If the claim is approved you will be paid whatever the approved amount was (the auction fee will NOT apply as the winning bidder will need to be refunded for the lost or damaged item). Certain items have a maximum insured value of \$500, such as antiques, artwork, and jewelry. See us for details.
